- ❖ Helmets are strongly recommended for all riders and required for jumping classes.
- ❖ Age as of first show holds through the season.
- ❖ Walk-Walk entries may not ride in Walk-Trot or Walk-Trot-Canter classes (excluding classes 12 & 17).
- ❖ Classes 1 & 40 open to everyone.
- ❖ A horse may not show in Walk-Trot and Walk-Trot-Canter with the same rider (excluding classes 1 & 40).
- ❖ Walk – Trot entries may show in classes 14 & 19 **if not** showing in classes 13 or 18.
- ❖ Walk –Trot entries may show in class 20 **if not** showing in classes 12 or 17.
- ❖ Riders entered in classes 44 or 45 may not show in 47 or 48.
- ❖ The **GREEN Horse** Classes are for horses or ponies, which are considered *new to the show ring*.
- ❖ A **GREEN Rider** is a horseperson *new to the show ring or new to riding*.
- ❖ **Best Original Costume** gift certificate awarded each show.
